- Cyan: Existing 24/7 disabled badge holders bay to remain.
- Orange: Existing 24/7 disabled badge holders to be revoked. Proposed disabled badge holders only Sunday to Friday 24 hours and Saturday 6pm - midnight. No waiting and no loading Saturday 6:30am - 6pm.
- Magenta: Existing no waiting and no loading at any time to remain.
- Blue: Existing limited waiting Monday - Friday 8am - 6pm 40 minutes no return 1 hour. No waiting Saturday 6:30am - 6pm to be revoked. Proposed limited waiting Sunday - Friday 8am - 6pm 40 minutes no return 1 hour. No waiting and no loading Saturday 6:30am - 6pm.
- Green: Existing loading bay Monday - Sunday 7:30am - 6pm to remain
- Red: Existing bus stop clearway 7am - 9pm and Taxi rank 9pm - 7am to remain.
- Brown: Existing 24/7 disabled badge holders 40 minutes no return 1 hour to remain.
- Purple: Existing no waiting at any time and no loading 10am - 2 pm to remain.
- Purple: Existing motorcycle bay Sunday - Friday to remain. Existing no waiting Saturday 6:30am - 6pm to be revoked. Proposed Saturday restrictions: Motorcycles only midnight - 6:30am and 6pm to midnight, no waiting and no loading 6:30am to 6pm.
- Orange: Existing no waiting at any time to be revoked. Proposed no waiting and no loading at any time.
